There have been four changes from the 06/22/04 version to the 12/21/07 version: 1) Damages—Blinds...removed, 2) Damages—Screen...rate change from \$20 to \$25, 3) Electric Utility Fee...added, & 4) Gas Utility Fee...added. The policy covering the electric and gas utility fees is on the back of this newsletter for clarification. The new schedule takes effect 02/01/08.
